BANKS STANDARD TERMS AND CONDITIONS

The Bank will use care and diligence in the selection of correspondent banks abroad.

The transfer instructions may be sent to the paying bank directly or through another bank as intermediary.

The Bank may utilise the services of other banks for the purpose of giving effect to the customers' instructions and does so for the account of and at the risk of the latter.

For the purpose of giving effect to its customers' instructions, the Bank will utilise as a paying bank:

- i. the paying bank nominated by the customer or, in the absence of such nomination
- ii. any bank, of its own or another bank's choice, in the country whose national currency is being remitted and/or the country where the beneficiary resides.

Any value date agreed by the Bank is the date on which funds will be available to the overseas bank. The ability of the overseas bank to pay the beneficiary on the same date will depend on banking practice in the country concerned.

The customer shall be bound by and liable to indemnify the Bank against all obligations and responsibilities imposed by foreign laws or usages over which the Bank has no control.
